



## FEDERAL REPUBLIC OF NIGERIA INSTRUMENT OF RATIFICATION OF THE AIR SERVICES AGREEMENT BETWEEN THE FEDERAL MILITARY GOVERNMENT OF THE FEDERAL REPUBLIC OF NIGERIA AND THE GOVERNMENT OF THE REPUBLIC OF LIBERIA

WHEREAS an Agreement between the Federal Military Government of the Federal Republic of Nigeria and the Government of the Republic of Liberia for Air Services between and beyond their respective territories was signed in Lagos on October 31st, 1978 for and on behalf of the Federal Military Government of Nigeria;

AND WHEREAS it is provided in Article 18(1) of the aforesaid Agreement that the Agreement shall be subject to ratification by the Contracting Parties and Instruments of Ratification shall be exchanged through diplomatic channels;

AND WHEREAS the Federal Military Government of the Federal Republic of Nigeria has by a decision duly reached in accordance with its constitutional processes agreed to ratify the aroresaid Agreement;

NOW, THEREFORE, I, LIEUTENANT\_GENERAL OLUSEGUN
OBASANJO, HEAD OF THE FEDERAL MILITARY GOVERNMENT,
COMMANDER-IN-CHIEF OF THE ARMED FORCES, FEDERAL REPUBLIC
OF NIGERIA, on behalf of the Federal Republic of Nigeria
hereby ratify the aforesaid Air Services Agreement
between the Federal Military Government of the Federal
Republic of Nigeria and the Government of the Republic
of Liberia.


